The Ohio Gastroenterology Society (OGS) invites Residents and Fellows to submit an abstract to be presented as a poster presentation at the 2019 annual meeting. This is an excellent opportunity to become involved in the OGS annual meeting and to enhance your reputation both within and outside your institution.

More than 100 gastroenterologists, residents, fellows and GI nurses are expected to attend this meeting. This event is designed to provide OGS members with the opportunity to discuss new treatment options and research, so as to advance towards excellence in clinical practice.

Submission and Review Process

Abstracts should relate to clinical or research oriented work in the field of gastroenterology. Abstracts will be considered if they have been accepted for presentation at other North American conferences. If the abstract is accepted, an author must commit to attending the OGS Annual Meeting to present their poster.

General Information

You may submit abstracts/posters of completed work, work in progress or work presented at a local or regional level. The primary author is responsible for obtaining written consent form all authors and appropriate institutions prior to submitting an abstract/poster. Abstracts/posters must be free of commercial bias. In addition, they may not imply an endorsement of any commercial product or service.

Individuals are limited to submitting two abstract applications. 14 abstracts will be selected for poster presentation.

SUBMISSION GUIDELINES AND REVIEW PROCESS

- Limit of two applications per individual.
- Each de-identified abstract will be reviewed by the OGS Education Committee for quality and content.
- Poster board size will be 6' wide by 4' tall. Your poster may be of any size smaller than these dimensions. Preseters are responsible for creating and bringing their own poster.
- You may submit abstracts/posters of completed work, work in progress or work presented at a local or regional level.
- The primary author is responsible for obtaining written consent form all authors and appropriate institutions prior to submitting an abstract/poster.
- Abstracts/posters must be free of commercial bias. In addition, they may not imply an endorsement of any commercial product or service.
- Authors are asked to be at their poster during the morning break.

Categories

You must designate one of the following categories for each abstract submitted. You may submit multiple abstracts:

- 1. Research
- Case Study

Title

The title should be brief and clearly state the content of the paper.

Authors

List the presenting author's name first. Give the name and location of the institution where the work was done. If the work was not done at an institution, list only the city and the state.

Body

The size limit for the body of the abstract (including any tables or figures) is 2,500 characters. Standard abbreviations may be used. Pictures are acceptable and simple tables and charts can be incorporated into the abstract. Organize the body of the abstract as follows:

- 1. Purpose of the study
- 2. Methods
- 3. Results Summary
- 4. Conclusion

New awards for 2019!

If your abstract is selected for a poster presentation, you will receive an award of \$100. If you cannot attend, you can send your poster with a colleague but only those who attend the meeting and are present to discuss/defend their poster during the break are eligible to receive payment. Set-up instructions will be confirmed later. In addition, the OGS will pay for your hotel room and tax for overnight accommodations at the Embassy Suites for one night, with arrival on Sept. 13. Even if you live close to Columbus, enjoy a night out on the OGS!

Outstanding Poster Awards

A \$200 award will be given to the outstanding poster in each of the two categories, voted on by the OGS review board.
